



UK&I Quality, Health, Safety & Environment Policy Statement

This policy statement sets out our commitment to achieving Worldclass quality, health, safety and environmental (QHSE) standards across our organisation and applies to all colleagues in our operating countries.

We are dedicated to delivering quality facility management services to our customers in a responsible manner, which safeguards the health and well-being of our colleagues, contractors, and the public, whilst operating sustainably and promoting the welfare of the communities in which we operate.

The UK&I Executive Committee is responsible for implementation of this policy and for assuring that the appropriate organisation and resources are in place to help us achieve our goals.
